Brief report Conveyance Allowance to students:-

Out of the grant sanctioned Rs. 10,00,000/- for the purpose, Rs. 2,00,000/- was received from the UGC and Rs. 3,340/- was raised by the college for total payment of conveyance allowance of Rs. 2,03,340/-.

Zero balance saving accounts of the eligible students were opened after due formalities of notice, interviews, verification of bus fare pass price, attendance and an amount equal to 2 or 3 months period conveyance allowance but not exceeding Rs. 500/- per month was paid into their respective bank accounts. The register of all eligible payee students is maintained by the college.
