Brief report

Merged Scheme SC/ST/OBC/Minority/Gen. Category Stipend

The scheme was applied by the college primarily to help the socially and economically backward students in the area. More than 35% of the college strength has been from socially backward society and the large part of general category students is economically backward. Hence, these students seek fee scholarship from social welfare department of the state on the basis of their non-creamy layer income size. Their lower income class is certified by the revenue authorities. Based upon its income class, 100 numbers of students were benefited. The brief profile of the students was as below:-
