The NRC was successfully commissioned in the month of April 2010 with a seating capacity of 10 students on **7 Desktop machines, 2 Laptops, 1 scanner, 1 printer, 1 network hard disk, 5 UPS, 1 LCD Projector screen, Storage (Table) 02 .**

For reliable and affordable connectivity BSNL MME-ICT scheme of HRD ministry was opted with 2 new broad-band lines of 2 mbps speed.
